Section 4: FIRST AID MEASURES

Eye Contact:	Immediately flush eyes with plenty of water for 15 -20 minutes, seek medical attention.

Section 6: ACCIDENTAL RELEASE MEASURES

Personal Precautions:	Use personal protection recommended in Section 8. Isolate the hazard area and Deny entry to unnecessary and unprotected personnel. Eliminate sources of ignition.
Environmental Precautions:	Many gases are heavier than air and will spread along ground and collect in low or confined areas (sewers, basements, tanks). This material is a water pollutant. Keep out of drains, sewers, ditches, and waterways. Minimize use of water to prevent environmental contamination.
